Pupils and teachers are encouraged to throw grain into poultry pens rather than hand feed birds. Pupils and teachers encouraged to be quite around animals. This includes, stroking away from the head, do not stroke faces and to let the animals roam in the session boxes. Animals that are known to nip are removed from public areas.
